ORDER

Consequent upon recommendation made by the Haryana Staff Selection Commission of selected candidates vide their Memo No. HSSC/Confid./Recomm-/2021/71 dated 24.02.2021, you are hereby offered a temporary post of Social Education and Panchayat Officer under Advt. No. 07/2015 Cat. No. 06 in the pay matrix- Level-6, pay range of Rs. 35400-112400 plus usual allowances as are admissible to the Government employees from time to time:

The above offer of appointment is further subject to the following terms and conditions:-

- Vijay K
- (i) It should be clearly understood that this offer of appointment is against a purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to him at present and in this respect he shall have to take his chance like others, who have been similarly recruited. Consequently, his service can be terminated, whenever there is no vacancy against which he can be retained.
 - (ii) If at any stage, he desires to resign his post in the department, he shall be required to give one month's clear notice or forfeit, in lieu thereof, his salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given him by Government also in case it is proposed to terminate his service for a reason other than that mentioned in sub para-i above. Government will also be liable to pay his salary including allowances for one month or for the period by which the notice falls short of one month in that case. However, in the case of misconduct he shall be given a reasonable opportunity to show cause as to why his service should not be terminated and in that case the condition of one month's notice will not apply;
 - (iii) It is also made clear to him that he shall not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies;
 - (iv) No TA will be granted for joining the appointment.
 - (v) He shall be on probation for a period of two years from the date of joining. The period of probation can be extended for a further period not exceeding one year, if his work and conduct is not found satisfactory.
 - (vi) He shall be governed by the Haryana Development and Panchayats Department (Group 'C') Service Rules (Field), 2012 as may be amended from time to time and also the Government instructions issued in this behalf;

- (vii) He should have not entered into or contracted a marriage with a person having spouse living or if he has a spouse living, should have not entered into or contracted a marriage with any person.
- (viii) He should appear before the Chief Medical Officer of District to which they belong and obtain from him a medical certificate of fitness after joining duty within the period of one month. In case, he has already been declared medically fit for Government services, a fresh medical certificate from the Chief Medical Officer of District will not be necessary.
- (ix) His seniority amongst Social Education and Panchayat Officers will be determined later on keeping in view the merit drawn by the Haryana Staff Selection Commission.
- (x) This offer is being made to him without verification of their character and antecedents from the Police Department and consequent upon submission of an undertaking to the effect by the candidates and in case, anything is found against them later-on, then his service will be terminated without any notice and without assigning any reason; and
- (xi) His Academic Qualifications/Age/Caste certificates have not been got verified and in case any misrepresentation/forged act is noticed at any later stage, then his service will be terminated without any notice and without assigning any reason; and
- (xii) The Contributory Pension Scheme/New Pension Scheme would be applicable after joining the service.

If he is willing to accept the offer of appointment on the above mentioned terms and conditions, he would report for duty to the O/o Director General, Development and Panchayat Department Haryana, Chandigarh within a period 15 days from the date of receipt of this letter.

While reporting for duty, he would bring with him the following documents:-

- i) Original and one set of self attested copies of their academic qualification, Age, Caste Certificate as the case may be;
- ii) Character Certificate from the two responsible persons not being related to them besides an undertaking to the effect that no criminal proceedings involving moral turpitude are pending against him;
- iii) Medical Certificate of fitness.


