**Subject: Regarding directions for the expenditure of 15<sup>th</sup> Finance Commission grants.**

On the subject cited above and above referred office memo no., all the Chief Executive Officers, Zila Parishads were informed to use the transfer module for executing the activities/works taken up in the eGramSwaraj portal by the executing agencies i.e. Block Panchayat or Gram Panchayat.

This matter was also discussed with Sh. Mohit Gupta, Consultant MoPR, wherein it was informed that Panchayats (ZP/PS/GP) can not transfer the XVFC funds to Govt. executive agencies like XENs- PR, BDPOs as the work is actually being carried by selected contractor or labour. Further, any payment done without eGramSwaraj-PFMS Interface (eGSPI) mode will attract audit objection.

You are, therefore, requested to add the bank account details of contractor and labour in eGSPI so that funds may be directly transferred to the bank account of such beneficiaries who are actually implementing the work at the Panchayat level (ZP/PS/GP). This will help the State to follow the instructions of MoPR for effective utilization of XVFC funds and avoid audit objections for the officials of Panchayats (ZP/PS/GP).
