
Subject:- Allocation of funds under Matching Grant Scheme for development works in the State of Haryana for the year 2015-16.

The Governor of Haryana is pleased to accord approval to the sanction of ₹1,00,00,000/- (₹ One Crore only) (₹33,34,000/- public share and ₹66,66,000/- Govt. share) to meet the expenditure relating to Matching Grant Scheme for construction of **building in Gujjar Kanya Mahavidhlaya of Kanya Vidhya Parcharni Sabha, Devedhar, Block Chhachhrauli, District Yamunanagar** in relaxation of the Matching Grants Rules, 1979.

2. Accordingly, an amount of ₹1,00,00,000/- (₹ One Crore only) (₹33,34,000/- public share and ₹66,66,000/- Govt. share) is allocated under Matching Grant Scheme for construction of building in Gujjar Kanya Mahavidhlaya of Kanya Vidhya Parcharni Sabha, Devedhar, Block Chhachhrauli, District Yamunanagar during the year 2015-16.

3. The expenditure in respect of Public Share and Govt. Share is debitable to the head "(P-01-32-2515-51-101-95-51)-2515-Other Rural Development Programme (Plan)-51-NA-09-Grant-in-aid (95) Matching Grant-in-aid for development works (Public Share)" and "(P-01-32-2515-51-101-93-51)-2515-Other Rural Development Programme (Plan)-51-NA-09-Grant-in-aid (93) matching Grant-in-aid for development works (Government Share)" respectively for the year 2015-16.

The provision made in the Haryana Matching Grants for Development Work Rules, 1979, and the instructions issued by the Government in this regard should be strictly adhered to and release orders may be issued for drawls of grant from the Treasury.
