

**PANCHAYAT DEPARTMENT HARYANA,**  
**ORDER**

In pursuance of the instructions issued by the Finance Department vide letter No. 2/2/2004-WM(3) dated 02-05-2012, sanction is hereby accorded under Rules 10.21 read with rule 10.22 of the Punjab Financial Rules, Volume-I, to the grant of Rs. 45000/- (Rupees Forty Five Thousand only ) to Sh. Shiv Kumar , Peon Office of the Director Development and Panchayat Department Haryana, Chandigarh for purchase of new Motor Cycle **Twister**.

The sanction is subject to the following terms and conditions:-

- i. The advance will be drawn in lump sum from the treasury in one installment.
- ii. Recovery of advance will commence with 1<sup>st</sup> issue of pay after the advance is drawn and advance will be recovered in 100 equal monthly installments.
- iii. The recovery of interest installment will start immediately after the principle is fully recovered.
- iv. The amount of advance along with interest will be recovered before his retirement i.e. 30.06.2034.
- v. Balance of advance and interest accrued thereon will be recovered from death-cum-retirement gratuity payable at the time of his retirement.
- vi. The Vehicle should be purchased by the loanee within period of one month after the drawal of amount from the Treasury as per note 3 of rule 10.21 PFR Volume-I. In case the loanee is unable to comply with the provision of rule, the entire loan alongwith penal interest should be recovered and deposited in the Treasury under advice to this Office and Finance Department Haryana.
- vii. The Loanee will have to execute a mortgage deed in PFR Form-22 as security for advance.
- viii. The loanee will have to submit Photostat copy of complete comprehensive insurance covering full risk of the vehicle and Registration Certificate within one month after the drawal of amount.
- ix. The rate of interest is 8.8% per annum but subject to change.
