Subject: Advisory regarding COVID-19

On the subject cited above, as you are aware that Hon'ble Prime Minister of India on 19.03.2020 at 08:00 PM addressed the nation regarding COVID-19. A meeting was held under the Chairmanship of Chief Secretary to Govt. of Haryana today i.e. 20.03.2020 to review the preparedness of the State on COVID-19. During the meeting CS, Haryana gave the following orders:-

1. Janta Curfew will be observed on 22<sup>nd</sup> March, 2020 (Sunday) from 7:00 AM to 9:00 PM in all the Gram Panchayats of the State.
2. Village Chowkidars of every village shall do the drum beating/munadi on 21.03.2020 (Saturday) in all the villages for mass awareness.
3. Village Chowkidar of every village shall blow a horn/houters/Munadi/Drum beating before 5:00 PM on 22<sup>nd</sup> March, 2020 so that inhabitants of the village come to doorsteps or balconies at 5:00 PM to appreciate the work of those involved in healthcare, sanitation and all other essential services day and night and either ring bells, bang on thalis or applaud.
4. Sarpanches to use Public announcement systems (wherever installed) also for this purpose.
5. Public dealing in Public offices may be discouraged to the extend of important or unavoidable matters
6. All the pubic offices to display a helpline/ office number alongwith the details of the person who is operating these members to that public can
