In pursuance of the instructions issued by the Finance Department vide letter No. 2/2/2004-WM(3) dated 02-05-2012, sanction is hereby accorded under Serial No. 1 of Rules 19.10 of the Punjab Financial Rules, Volume-I, read with rule 10.16 ibid and the instructions contained in Haryana Government Finance Department letter No. 1750-WM(1) 76/9190, dated the 12th March, 1974, as amended from time to time, to grant of House Building Advance amounting to Rs. 5,00,000/- (Rs. Five Lac only) Sh. Ram Singh, Patwari office of the Block Development & Panchayat Officer, Uklana, District Hissar for the purchase of built up House at Uklana Mandi District Hissar.

The sanction is subject to the following terms and conditions:-

- i. The advance will be drawn in lump sum from the treasury in one installment.
- ii. Recovery of advance will commence with 1st issue of pay after the advance is drawn and advance will be recovered in 80 equal monthly installments.
- iii. The recovery of interest installment will start immediately after the principal is fully recovered.
- iv. The amount of advance along with interest will be recovered before his retirement i.e. 31.03.2021.
- v. Balance of advance and interest accrued there on will be recovered from death-cum-retirement gratuity payable at the time of his retirement.
- vi. The rate of interest is 8.8% per annum but subject to change.

The provision of rule 19.10 of Punjab Financial Rules, Volume-I has been fulfilled in this case.

It is certified that all the formalities required under the rules/instructions have been completed and loan is fully secured and will be recovered from the loanee.

The DDO of this amount is Block Development & Panchayat Officer, Uklana, District Hissar. The authority is valid upto 30.09.2013.

The amount will be debited to the Major Head "7610 Loans to Govt. Servants etc. (Non Plan)-51-201-House Building Advance -99-Advance to Govt. Servants other than AIS Officers (99) - Advances other than DQ-50-Advances during the year 2013-14.
