Subject:- Allocation of funds under Matching Grant Scheme for development works in the State of Haryana for the year 2019-20.

The Governor of Haryana is pleased to accord approval to the sanction of ₹ 15,00,000/- (₹ Fifteen Lakh only) (₹ 5,00,000/- public share and ₹ 10,00,000/- Govt. share) to meet the expenditure relating to Matching Grant Scheme for construction of **two rooms in Government Girdl Senior Secondary School Dhobhi**, Block Hisar-II, District Hisar.

2. Accordingly, an amount of ₹ 15,00,000/- (₹ Fifteen Lakh only) (₹ 5,00,000/- public share and ₹ 10,00,000/- Govt. share) is allocated under Matching Grant Scheme for construction of two rooms in **Government Girdl Senior Secondary School Dhobhi**, Block Hisar-II, District Hisar.

ORDER

In pursuance of the Haryana Civil Services (Compassionate Financial Assistance or Appointment) Rules, 2019 notified vide No. GSR.32/Const./Art.309/2019 dated 02.08.2019 Kumari Vani Sharma D/o Late Smt. Radha Sharma is hereby offered a temporary post of Clerk under Ex-gratia scheme in the pay matrix-Level pay range of Rs. 19900-63200 plus usual allowances as are admissible to the Government employees from time to time.

The above offer of appointment is further subject to the following terms and conditions:-

- i) It should be clearly understood that this offer of appointment is against a purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to her at present and in this respect she will have to take her chance like others, who have been similarly recruited. Consequently, her services can be terminated, whenever there is no vacancy against which she can be retained;
- ii) If at any stage, she desires to resign her post in the department, she will be required to give one month's clear notice or forfeit, in lieu thereof, her salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to her by Government also in case it is proposed to terminate her service for a reason other than that mentioned in sub para-i above. Government will also be liable to pay her salary including allowances for one month or for the period by which the notice falls short of one month in that case. However, in the case of misconduct she will be given a reasonable opportunity to show case as to why her service should not be terminated and in that case the condition of one month's notice will not apply.
- iii) It is also made clear to her that she will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies;
- iv) No T.A. will be granted for joining the appointment;
- v) She will be on probation for a period of two years from the date of joining. The period of probation can be extended for a further period not exceeding one year, if her work and conduct is not found satisfactory;
- vi) She will be governed by the Haryana Development and Panchayat (Group-C) Field Office Services Rules, 2013 as may be amended from time to time and also the Government instructions issued in this behalf;
- vii) They shall have to qualify State Eligibility Test in Computer Appreciation and Applications (SETC), as stipulated under rule 9A of Haryana Development & Panchayats Department Group C (Field Offices) Service Rules, (1st Amendment) 2013 if their case does not cover under the exemption category referring to the ibid provisions, to earn any increments in their pay scale. In case, they fail to qualify the test within stipulated period their services shall be dispensed with.
- viii) She would have not entered into or contracted a marriage with a person having spouse living or if she has a spouse living, should have not entered into or contracted marriage with any person;
- ix) She should appear before the Chief Medical Officer, Faridabad and obtain from her a medical certificate of fitness before joining duty. In case she has already been declared medically fit for Government Services a fresh medical certificate from the Chief Medical Officer of the District will not be necessary;
- x) Consequent upon joining the service, she would be member of Field Offices Service and her interse seniority will be determined later on as per rules.
- xi) This offer is being made to her without verification of her character and antecedents from the Police Department and consequent upon submission of an undertaking to the

- effect by the candidates and in case, anything is found against her later-on, then her services will be terminated without any notice and without assigning any reason;
- xii) Her Academic Qualification/Age/Caste certificates has not been got verified and in case any misrepresentation/ forged act is noticed at any later stage, her service will be terminated without any notice and without assigning any reason.
- xiii) The Contributory Pension Scheme/New Pension Scheme would be applicable after joining the service;

Consequent upon her appointment to the post of Clerk she is posted in the office of Executive Engineer, Panchayati Raj, Faridabad.

If she is willing to accept the offer of appointment on the above mentioned terms and conditions, she would report for duty to the concerned office within a period 15 days from the date of receipt of this letter.

While reporting for duty, she would bring with her the following documents:-

- i) Original and one set of self attested copies of their academic qualification, Age, Caste Certificate as the case may be;
- ii) Character Certificate from the two responsible persons not being related to her besides an undertaking to the effect that no criminal proceedings involving moral turpitude are pending against her;
- iii) Medical Certificate of fitness.
