The Governor of Haryana is pleased to accord sanction for release of funds amounting to Rs. 10,31,000/- (Rs. Ten lakh and Thirty One Thousand only) as Grant-in-aid to Gram Panchayat Village Kohla, Consty., Baroda, Block Mundlana, Distt. Sonipat for Construction of Brick on edge Rasta (from Nurankher, Road to Ghadwal Road) F/O Sh. Jasbir S/o Sh. Dhara to F/o Sh. Bhim S/o Ballu (Name of Villages and Suggestive list of works enclosed) under the Haryana Gramin Vikas Yojana Scheme (Normal Plan) during the current financial year 2020-21.

The Govt. has also decided that the Special Secretary, Development Department will be the drawing and disbursing officer of the said amount being allocated to Gram Panchayat Village Kohla, Consty., Baroda, Block Mundlana, Distt. Sonipat. It shall draw the amount from Govt. Treasury and deposit the same in the bank accounts of concerned Gram Panchayat Village Kohla, Consty., Baroda, Block Mundlana, Distt. Sonipat as per the list enclosed.

The sanction is subject to the following conditions:-

1. That in compliance of instructions issued vide memo no. DFA-3-2017/63435-533 dated 07-06-2017 and DFA-3-2017/69692 dated 30.06.2017, HRDF-2018/16-100 dated 04.04.2018 the funds shall be provided directly to the Gram Panchayat.
2. That the work shall be executed as per Haryana Panchayati Raj Finance, Budget, Accounts, Audit, Taxation and works Rules and instructions issued from time to time.
3. That after completion of the work, the utilization certificate of the grants must be sent within time.
4. That the Gram Panchayat would start the work as early as possible following duly approved procedure as per rules and ensure the timely completion of the work.

5. That before start of work it shall be ensured that the works/projects being undertaken are covered under the guidelines/instructions issued by the State Government from time to time and funds have not been sanctioned earlier under any scheme for the same work/project.
6. The Gram Panchayat is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
7. The Gram Panchayat, by majority shall pass resolution for issuing administrative approval of works.
8. Before start of execution of work proper estimates of the works shall be prepared and technical approval shall be granted by the competent authority.
9. The grant is further released with the condition that if any sewerage work is to be started or ongoing within the current financial year, the works shall be taken up afterwards.
10. Unspent amount & interest be returned to this office after completion of work without any delay.
11. The work is to be executed at Revenue land/Rasta which is earmarked/ ownership in the name of concerned Gram Panchayats.
12. The works should be undertaken strictly as per guidelines conveyed vide letter No. PRA-1-2009/650-70, dated 19/02/2009 where by the Schemes of Special Development Works HGVY were issued.

The expenditure involved will be debited under major head code P-01-32-2515-51-102-94-51(43) under Scheme 'Haryana Gramin Vikas Yojana' (HGVY) for the year 2020-21.
