Subject: **Release of funds for various development works in the village of Distt. Ambala under Haryana Gramin Vikas Yojana Scheme (Normal Plan) during the current financial year 2020-21 (CM Code 25284).**

The Governor of Haryana is pleased to accord sanction for release of funds amounting to **9,90,000/- (Rs. Nine Lac Ninety Thousand Only)** as Grant-in-aid to Gram Panchayat of District Ambala for various development works in the villages (Name of Villages and Suggestive list of works enclosed) under the Haryana Gramin Vikas Yojana Scheme (Normal Plan) during the current financial year 2020-21.

The Govt. has also decided that the Special Secretary, Development Department will be the drawing and disbursing officer of the said amount being allocated to Gram Panchayat of district Ambala. He shall draw the amount from Govt. Treasury and deposit the same in the bank accounts of concerned Gram Panchayat of district Ambala as per the list enclosed.

The sanction is subject to the following conditions:-

1. That in compliance of instructions issued vide memo no. DFA-3-2017/63435-533 dated 07-06-2017 and DFA-3-2017/69692 dated 30.06.2017, the funds shall be provided directly to the Gram Panchayat.
2. That the work shall be got done as per Haryana Panchayati Raj Finance, Budget, Accounts, Audit, Taxation and works Rules and instructions issued from time to time.
3. That after completion of the work, the utilization certificate of the grants must be sent within time.
4. That the Gram Panchayat would start the work as early as possible after observing/Completing all the formalities and ensure the timely completion of the same.
5. That before start of work it shall be ensured that the works/projects being undertaken are covered under the guidelines/instructions issued by the State Government from time to time and funds have not been sanctioned earlier under any scheme for the same work/project.
6. The Gram Panchayat is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
7. The GP, by majority shall pass resolution for issuing administrative approval of works.
8. Before start of execution of work proper estimates of the works be framed and technical approval be granted by the competent authority.
9. The work is to be executed in Revenue Rasta which is earmarked in the name of Gram Panchayat.
10. That the work to be executed, shall be identified by the concerned Gram Panchayat by passing a resolution by majority.
11. As soon as the Gram Panchayat concerned accord administrative approval if any, for a specific work against the sanctioned amount, the detail of the same be conveyed to this office within a week thereafter.
12. The works should be undertaken strictly as per guidelines conveyed vide letter No. PRA-1-2009/650-70 dated 19/02/2009 where by the Schemes of special Development Works was issued.
