- 3. That after completion of the work, the utilization certificate of the grants must be sent within time.
- 4. That the Gram Panchayat would start the work as early as possible after observing the formalities and ensure the timely completion of the same.
- 5. That before start of work it shall be ensured that the works/projects being undertaken are covered under the guidelines/instructions issued by the State Government from time to time and funds have not been sanctioned earlier under any scheme for the same work/project.
- The Gram Panchayat is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
- The Gram Panchayat, by majority shall pass resolution for issuing administrative
  approval of works.

The grant is further released with the condition that if sewerage work is to be started within the current financial year, the works be taken up afterwards.
