Subject: Release of funds for various development works in the villages of Distt. BHIWANI under Haryana Gramin Vikas Yojana Scheme (SCSP Component) during the current financial year 2017-18 (Plan).

The Governor of Haryana is pleased to accord sanction for release of funds amounting to ₹ 1,68,91,200/- (₹ One Crore Sixty Eight Lac Ninety One Thousand Two Hundred Only) as Grant-in-aid to Gram Panchayat of District BHIWANI for various development works in the villages (Name of Villages and Suggestive list of works enclosed) under the Haryana Gramin Vikas Yojana Scheme (SCSP Component) during the current financial year 2017-18.

The Govt. has also decided that the Joint Secretary, Development Department will be the drawing and disbursing officer of the said amount being allocated to Gram Panchayat of district BHIWANI. He shall draw the amount from Govt. Treasury and deposit the same in the bank accounts of concerned Gram Panchayats of district BHIWANI as per the list enclosed.

The sanction is subject to the following conditions:-

1. That in compliance of instructions issued vide memo no. DFA-3-2011/36392-480 dated 18-07-2011, the funds shall be provided directly to the Gram Panchayats.
2. That the work shall be got done as per Haryana Panchayati Raj Finance, Budget, Accounts, Audit, Taxation and works Rules and instructions issued from time to time.
3. That after completion of the work, the utilization certificate of the grants must be sent within time.
4. That the Gram Panchayat would start the work as early as possible after observing the formalities and ensure the timely completion of the same.
5. That before start of work it shall be ensured that the works/projects being undertaken are covered under the guidelines/instructions issued by the State Government from time to time and funds have not been sanctioned earlier under any scheme for the same work/project.
6. The Gram Panchayats is advised to execute the work strictly in accordance with the guidelines issued by the Government from time to time.
7. The GP, by majority shall pass resolution for issuing administrative approval of works.
8. The GP shall also mention that in case the estimated cost of a work is upto Rs. 10 lac the work be got executed by the Gram Panchayat strictly as per instructions issued vide letter no. DFA-3-2011/36392-480, DFA-3-12/48328-415 and DFA-3-15/4162-4252 dated 18.07.2011, 24.08.2012 and 05.02.2015 and in case the estimated cost of a work

above ₹10 lacs the work should be got executed through XEN(PR) as envisaged under these instructions.

9. Before start of execution of work proper estimates of the works be frame and technical approval be granted by the competent authority.

The expenditure involved will be debited under major head code P-01-32-2515-51-789-97-51 under Scheme 'Haryana Gramin Vikas Yojana' (HGVY) for the year 2017-18.
