## Development & Panchayats

### Advertisement

Some posts of Block Development and Panchayat Officer are lying vacant in this department due to which the Development Works are suffering badly. Hence, it has been decided by the Govt. to fill up these vacant posts on contract basis out of the retired Block Development and Panchayat Officer /District Development and Panchayat Officer who fulfill the following conditions:-

- (i) An offer be given to all those BD&POs/DD&POs who have retired prior to coming into force of this notification, and are below 64 years of age, to be appointed on contract basis in the Development and Panchayats Department on the principal of last pay drawn minus pension for discharging their duties. This offer may be given to only those BD&Pos and DD&Pos who are below 64 years of age and have at least one year remaining to attain the age of 65 years on the date of filling their application form appointment.
- (ii) Their pay will be notional fixed in the revised pay scales after 1<sup>st</sup> January 2016 and on that basis their revise pension will be deducted from the revised pay and the remaining amount will be given to them as the salary. They will also be entitled to the benefit of DA as announced by the Govt. from time to time. The benefit of DA will be admissible towards pension as well as revised salary.
- (iii) Only retired BD&POs/DD&POs with clean service record shall be considered for contractual engagement, who have no disciplinary or criminal proceedings pending against them and those have not been convicted or inflicted with major penalty by any disciplinary authority or any court of law.
- (iv) The engaged officers shall be expected to discharge their duties strictly in accordance with applicable rules and instructions.
- (v) Initially the engagement will be for a period of one year or till the regular selected candidates are sponsored by the recruiting agency whichever is earlier. The contract period can be extended depending on the administrative need subject to satisfactory performance.
- (vi) The incumbent will be entitled to TA/DA, leave etc. as per Government rules.
- (vii) BDPOs who are still in service, may apply two months prior to attaining age of 58 years for further contractual engagement beyond 58 years under this policy.
- (viii) If any officer is found guilty of misconduct, misappropriation, embezzlement etc. during the tenure of contractual service or at any time thereafter, the same

shall be dealt with in accordance with rules, including criminal action and recovery etc.

- (ix) The incumbent shall have to give two months prior notice in case he wishes to terminate the contract.
- (x) The Government reserves the right to rescind the agreement of the engaged officer and relieve him of the charge at any time without notice, in case his work and conduct is not found satisfactory or the exigencies so require.
- (xi) Since most of the retired officers have settled in their own district and may not like to move to a different place for contractual employment, the condition may be waived of for these contractual appointments. The selected candidates can be posted within District in Haryana.
- (xii) They will exercise the powers of drawing and disbursing officer after obtaining approval from concerned DDPO and the concerned DDPO shall be bound to exercise due check over such BDPOs. If the post of DDPO is vacant such approval may be obtained either from concerned Deputy Chief Executive Officer Zila Parishad or Chief Executive Officer Zila Parishad.
- (xiii) Any retired BDPO/DD&POs who fulfills all terms and conditions can apply to the Department.

The interested retired officers may apply in this regard in the given format to the office of Principal Secretary to Govt., Haryana, Development and Panchayat Department, 3<sup>rd</sup> Floor (ECD-1 Branch) New Haryana Civil Secretariat, Sector 17-C, Chandigarh within 15 days from the date of publication.
